 - d. Causes of lack of ECEC
 - e. # of centers could serve? But is employment of providers the problem?
 - f. # of facilities is right- the number of children is not.
 - g. # of children is under-reported.
- 2) What impact did Covid have on early childcare providers in the region?



- a. Providers lost
- b. Classroom sizes shrunk
- c. Families found alternatives
- d. Families working from home
- e. Center's hours more restrictive after covid.
- f. Effected staffing
- g. Summer programs harder to find too.
- h. Less people willing to work with children because of increased disciplinary issues.
- i. Babies non-socialized after 2 years of lockdown are struggling in programs- harder for workforce.
- j. ECEC sites were shutting down before COVID due to unstable funding sources and increased unfunded mandates.

- 4) What is the current FPL, FPL 100%, FPL 200%? Can families within those FPLs afford childcare in our region?
