*Solutions for Providers:

- *Increased wages and benefits resulting in:
 - -More employees,
 - -Employee Retention
 - -Should include Head Start and other entities
 - +Limits competition and job hopping
 - -Should be supplemented financially
 - +By those benefiting (Business)
 - +Community organizations collaborating together
 - +Not by increased costs to families
- *Replace the competitive grant funding model with a funding model that values the development of all children regardless of race, ethnicity, culture, religion, zip code
- *"Red Tape" needs to be simpler
 - -Many home providers have HS diplomas



-Improving quality is often tied to education and creates roadblocks

*Translation documentation could be done Regionally based on need

- -Eliminates delays from State agencies approval and completion
- *DCFS communication clear, consistent, and supportive instead of restrictive
 - -Specify rules and regulations
 - -Give providers longer timelines and assistance if regulations change
 - -Standardize policy across monitoring agencies (DCFS/Fire Marshall)
 - -Allow Directors to remain open while progressing
 - +While pursuing their degree
 - +Emergency license Directors like ISBE does Teachers
