Notes: Regional Council Manager presented Systems Building video and the importance of functional community systems.



#### Questions that Remain Unasked/Unanswered

Notes: Action Council members raised questions that are tabled for future discussion and research.

- How can there be assurance that all programs will be supported and funded adequately? Do expectations match the supports needed to implement services? (Bilingual/Multilingual, English Language Learners, Special Education, children with differing abilities)
- Are refugee and immigrant populations being served in a just manner?
- How is the workforce gap addressed, specifically regarding pay equity?
- ECEC funding to match K-12 funding?
- ISBE & IDHS working together to create seamlessness between programs?
- Is there a possibility of Universal Preschool?
