11:05 am-11:30 am: Focused Conversation (25 Minutes)

Notes: Action Council members were invited to think about racial inequity, its' impact on early childhood education, and care in the region and what actions can help promote racial equity. As we move into our next phase of work, our next Council meetings will focus on the Addendum. Council members were updated on details of the Addendum which will be adding and or clarifying information/ feedback on the Early Childhood Regional Needs Assessment. The Council also discussed details of our Fall work, which is the Action Plan that we will begin working on locally as a Council.

- What voices were missing from the Early Childhood Regional Needs Assessment? What strategy can we use to engage them?

Some responses included:

- Families experiencing homelessness and Refugees have been the hardest groups to engage in our work. These voices are missing from our Early Childhood Regional Needs Assessment.
- The IRIS System (referral database) needs to be across all counties throughout the state, not a county-specific program.
- The need for more resources for areas that need it most is crucial to being able to engage them. Housing assistance is backed up and lack of transportation are big concerns and needs for families in the Region.
