Notes: An overview was provided to discuss how the Action Plan will be used during Year 2. Council members were given a list of recommendations made for the Early Childhood Regional Needs Assessment. As a council, we will decide what 2-3 recommendations to work on.

IV. Recommendation: Create a centralized hub for resources and services

Notes: A recommendation was made based on feedback from families and providers during the Regional Needs Assessment process.

Why was the recommendation made?

- Make it easier for parents and families to find Early Education Programs and Services.
- Improve Awareness of current programs (along with contact information).
- There are so many resources and different programs it will be helpful to know if they are funded by the state and/or private funding.



- Allows us to take everyone's knowledge and collect it together in one space. (One Stop Shop for all information.
- If we want to improve services, we need to know where they are currently located.
- Easier to get feedback from parents and providers (Surveys and Interviews).
- Important to have a comprehensive list to ensure effort and services are not duplicated.

What data supports the recommendation?

- Programs currently have openings, but families are not aware of them.
- We don't have an idea of providers' status if they are open and have enrolment openings.

What are the SMART goals that must be achieved to implement this recommendation?

- Create a comprehensive list of ECEC providers in the Region within 10 months in order to create a user-friendly website to help parents find suitable ECEC options for their children.
- Create a comprehensive list of ECEC providers in the Region within 10 months in order to create a user-friendly website to help parents find suitable ECEC options for their children.
- Identify someone to create and maintain the website.

What are the goals that must be achieved to implement this recommendation?

- When we have an established comprehensive website of programs and services that makes it easier for parents and families to find Child Care.
- When all the sub-goals are achieved.
- We are hoping to meet the goals within 12 months.

What are the anticipated risks/barriers to achieving the goals?

- Different programs use different databases and reporting forms.
- Real-time Data (Current openings) are missing.

What are some proposed solutions to the anticipated risks/barriers?

- When a child is enrolled at a provider, they are enrolled into different databases.
- Create a centralized system for enrollment.
- Receive information from Gateways INCCRRA.
- Get real-time data during Mandated meetings (Smart Start, Quality Improvements) and make it a requirement to update enrollment information.
- Review and create something similar to EPEL Elgin Partnership for Early Learning and send out monthly newsletters.
