5:30pm: Went over the Community Agreements, did introductions, and Ice Breaker. Stated how the Early Childhood Regional Needs Assessment is LIVE, & Council Interest forms are still open and provided a State update. Notes:

- Ashley went over the Community Agreements since we had both Action and Family Council at the same meeting.
- The councils engaged in introductions and an "Ice Breaker" (*This or That*) to help build more personal relationships between the two councils.
- Ashley let the Councils know the Early Childhood Regional Needs Assessment is now LIVE.
