 - e. More resource guides need to be available to parents for post-partum issues. No resources given just medicine, couldn't breastfeed- police called for wellness check- need more outsourcing supports- parents learning how to regulate their emotions help them teach and soothe their children.
 - f. Supports needed for traumatic birthing experiences
 - g. It is suggested that training be made available to parents and service providers that specialize in ages under 8 years old most people trained for adults and older kids, but not young children.
 - h. NICU experiences very common No NICU at Kishwaukee (since 2 years ago,) Need a NICU in DeKalb County, explore why we
