- Reviewed the warning signs of Mental Illness in children and discussed the dierences in adult and child mental health.

2:50 pm: Mental and Behavioral Health Services Landscape Discussion (60 minutes). Notes:

- Introduced data on the need for and locations of Mental and Behavioral Health Services in DuPage County. However, it was noted that most of the data is only available for adolescents and adults.
- ∉ Council members discussed:
 - o The use of screening tools, Infant/Early Childhood Mental Health Consultants, and the Pyramid Model.



- o The di erence between supporting the overall mental health and development of children versus a child who has received an o cial diagnosis of a mental illness, especially in relation to medical needs.
- o A mindset that supports the notion that what is most urgent for us may not be what is most urgent for families and the importance of having professionals that represent the populations they serve.
- o How one partner, when o ering Infant/Early Childhood Mental Health screenings as part of new enrollment, rarely referred to their Infant/Early Childhood Mental Health professional as "Doctor" to help families be more receptive to mental health services.
- o Trauma screenings should start with the family, not the child and prior to the child being born. Caregivers can be in denial about their own trauma, diagnosis, or situation as well as that of their child.
- o Trauma is inevitable and can begin in the womb.
- o What barriers exist and why?
